

**MINUTES OF THE MEETING OF THE BOARD OF EDUCATION

The regular September Board of Education meeting of Boone County School District 06-0075 a.k.a Riverside Public Schools was convened in open and public session on Wednesday, September 12, 2018 at 7:00 p.m. in the Riverside Public School teachers' workroom, Spalding site, Spalding, NE.
